• Bernardo Fanfani (Post-doc Research Fellow, Facoltà di Economia)



Bernardo Fanfani is a post-doctoral research fellow at the Catholic University of Milan. He is a labour economist who has worked on discrimination, wage inequality, industrial relations and the economic effects of collective bargaining. One of his papers on the evolution of Italian wage inequality has been published by the *British Journal of Industrial Relations*, and the Italian Society of Public Economics has awarded the E. Chiuri prize to his paper on discrimination against women. He has collaborated with Italian and international institutions, such as

UNICRI, ILO and the Italian Social Security Institute (INPS). He obtained his PhD from Collegio Carlo Alberto and the University of Torino and he has been a visiting student researcher at the University of California, Berkeley.

# • Luca Gerotto (Post-doc Research Fellow, Facoltà di Economia - Campus di Roma)



Luca Gerotto is a research grant holder at the Department of Economics and Finance, where he joined the research group in health economics led by Prof. Gilberto Turati, and a research fellow at the Department of Economics of Ca' Foscari University of Venice. He has a PhD in Economics earned in Venice in March 2018, with a dissertation on computational methods for policy making. After the degree, he spent another year in Venice, thanks to a research grant on epidemiological models of expectation formation, and

one year at the Observatory on Italian Public Accounts of Università Cattolica del Sacro Cuore, directed by Prof. Carlo Cottarelli. His research interests focus on public economics, agent-based macroeconomics and macroeconomics, with a particular focus on expectations formation and the macroeconomic effects of households expectations.

### • Daniela Maggioni (Associate Professor, Facoltà di Economia)



Daniela Maggioni is Associate Professor of Economics at the Catholic University of the Sacred Heart. Before joining the Department, she has been Associate Professor and Assistant Professor (RTDb) at the Ca' Foscari University of Venice, Assistant Professor (RTDa) at the University of Catania and post-doc researcher at Marche Polytechnic University. She holds a PhD in Economics from Marche Polytechnic University. Her research interests span international trade, economic geography and industry dynamics. In

her recent work, she has investigated the effects of trade and FDI on innovation, the geographical evolution of the production structure and the impact of religion on trade flows. She is currently studying the role of immigrants in affecting the local product mix and the impact of robot adoption on labour outcomes.

#### • Luca Stella (Assistant Professor, Facoltà di Scienze Politiche e Sociali)



Luca Stella is an Assistant Professor at Università Cattolica del Sacro Cuore. Before that, he worked as a Post-Doctoral Researcher at Bocconi University and the University of Wuppertal. He has received the B.Sc. and M.Sc. in Economics and Social Sciences from Bocconi University, and obtained the Ph.D. in Economics at the University of Padua. While working on his doctorate, he spent two years as a visiting student at Boston University. He is a Research Affiliate at IZA and a Research Fellow at

the Dondena Centre for Research on Social Dynamics and Public Policy. Luca Stella's work focuses on three main areas: the effects of technological change on health and life-course choices, the economics of immigration and the economics of the family.

## • Ciro De Florio (Secondary affiliation, Facoltà di Economia)



I am Associate Professor of Logic and Philosophy of Science at Faculty of Economics, Università Cattolica, Milan.

My area of research are: mathematical logic, philosophy of logic and mathematics, philosophy of science. I am interested in the relationships between formal knowledge and classical philosophical topics, especially ontological and epistemological ones. Particularly, I dealt with: higher order logical systems, characterization of

the standard model of natural numbers, the formalization of the logical consequence and logical analysis of the truth-predicate.

Presently, I am working on: systems of logic for illocutionary acts; the characterization of the nexus of logical consequence in terms of conceptual grounding; models of temporal logic. I am planning to start a research on foundations of decision theory, connected with epistemic and temporal features. I love mountains and mountaineering, best with my family and friends.

• Silvana Robone (Secondary affiliation, Department of Economics, Università degli Studi dell'Insubria)



Silvana Robone is Associate Professor at the Department of Economics, University of Insubria (Varese), where she teaches courses at undergraduate level (Economic Policy, Health Economics) and PhD level (Applied Health Economics). She also serves as Vice-Director of the BA program in Economics and Management and as a Member of the Board of the PhD Program at the Department of Economics of the University of Insubria. Her education includes a BA degree in Economics and

Social Science awarded by Bocconi University, two Masters awarded by Bocconi University (one in Economics and one in Economics and Management of Public Utilities) and a Ph.D. in Economics awarded jointly by the University of York, UK and the University of Bologna, Italy.

Silvana has been employed from 2006 to 2012 as Research Fellow at the Centre For Health Economics (CHE), University of York, where she worked with of Prof. A.M Jones, Prof. N. Rice and Prof. P.C. Smith. She has been Assistant Professor (rtd A) at the Department of Economics, University of Bologna, since 2012 to 2014, and Assistant Professor at the Department of Economics, University of Insubria since 2014 to June 2017. Silvana is currently involved in research projects investigating the performance of the NHS in several countries (i.e. Italy and Spain), the relationship between working conditions and health, and behavioural aspect of health.

Results from the research activity of Silvana have been published on journals such as the Journal of the Royal Statistical Society (series A), the Journal of Health Economics, Health Economics, Regional Science and Urban Economics, the American Journal of Health Economics, Social Science & Medicine, the European Journal of Health Economic, and the International Journal of Health Care Finance and Economics.
