

Marco Buso (Assistant Professor RTD-A, Faculty of Economics)



Marco Buso is a research fellow in the department of economics and finance at "Università Cattolica del Sacro Cuore". He has worked as a post-doc researcher in the Bureau for Economic Theory and Applications (BETA) at the French National Institute for Agricultural Research (INRA) and in the department of economics and management at the University of Padova. He completed his Ph.D. in Economics at the University of Padova in 2014. During his Ph.d, he was visiting at the Toulouse School of Economics (TSE) and at the Sorbonne Business School in

Paris. His research interests include mechanism design applied to public economics, public procurement and industrial organization; econometric methods for public policy evaluation; and the effect of public policies for environmental protection.

#### • Simona Gamba (Assistant Professor RTD-A, Faculty of Economics)



Simona Gamba is Assistant Professor (rtd A) at the Catholic University of Milan, Department of Economics and Finance. She obtained her Ph.D. in Public Economics from DEFAP (Graduate School in Public Economics), Catholic University of Milan, in 2015. She holds a bachelor's degree in Management of Public Administration and International Institutions from Bocconi University and a master in Economics of International Development from the "Institut d'études

politiques" (Sciences Po), Paris. Her main areas of scientific interest include innovation, global and cross-national politics of Intellectual Property Rights, public health and public finance. She previously worked as a post-doc researcher at the University of Verona, Department of Economics, as a research fellow at FBK-IRVAPP (Research Institute for the Evaluation of Public Policies) in Trento, and as a research assistant at IMT (Institute for Advances Studies of Lucca). She worked as adjunct professor for the course of Public Finance (University of Verona), and as a teaching assistant for the course of Microeconomics (University of Milan), Public Finance (Bocconi University), Labour Economics (Catholic University).

#### • Arianna Galliera (Assistant Professor RTD-A, Faculty of Law)



My name is Arianna Galliera and I am Assistant professor (Ricercatore RTDa) at Università Cattolica del Sacro Cuore. I am aslo fellow at CEAR (Center for the Economic Analysis of Risk), Georgia State University (GSU) and Affiliated Scientist at RFF-CMCC European Institute on Economics and the Environment.

I have completed my PhD at LUISS in 2016; my doctoral dissertation was an essay on experimental economics and individual decision making related to public good games, bargaining problem, gender issues, cooperation, and

cognitive bias. My current research focuses mainly on experimental (field and lab), behavioral economics, and environmental economics. I am interested in individual decision making and risk preferences.

Nowadays I work on different projects. First, I am working on projects involving surveys and lab-in-the-field experiments: a project in El Salvador where we analyze the correlation between violent environment and student social and risk preferences; the Portfolios of the Atlanta Poor project aims at understanding how poor and low-income households manage financial, health, security and family aspects and how these decisions depend on the risk and uncertainty. A second set of field projects is related to energy use, environmental efficiency and big data; in this sense, I collaborate with energy providers to set the energy interventions. Finally, I work on social preferences, coordination problems and risk preferences using laboratory experiments.

#### • Giulia Rivolta (Assistant Professor RTD-A, Faculty of Economics)



Giulia is an empirical macroeconomist. She holds a Bachelor and a Msc degree in Money, Banking and Finance from the University of Brescia and she received a PhD in Economics from the University of Milan in 2015. During her doctoral studies, she spent one year as Research assistant at the Monetary policy research department of the European Central Bank in Frankfurt in 2013-2014. Then she spent 4 years as Postdoctoral Fellow at the University of Brescia.

Her main research interests are monetary policy and international spillovers. Her expertise is in VAR modelling, identification, Bayesian inference and non-linear time-series models.

# • Duccio Gamannossi degl'Innocenti (Post-doc Research Fellow, Faculty of Economics)



Duccio Gamannossi degl'Innocenti graduated in Economics at the University of Florence and was awarded his PhD in Economics from IMT, Lucca. From 2017 to 2019 he was a post-doctoral researcher at TARC (Tax Administration Research Centre) of the University of Exeter, where he is now an Associate Fellow. His primary research interests are on Public Economics and entail topics in Taxation, Tax Compliance and Local Government Efficiency. His current research investigates

how social networks might influence taxpayer compliance, optimal exemption thresholds for value-added taxes in multi-level production chains and the use of conditional frontier models to assess local government efficiency.
