She is Full Professor of Economics at the University of Rome Tor Vergata, Research Fellow at CEPR London and IEFE-Bocconi. Her main research interests are in applied economic theory, with particular focus on public service provision, public procurement, procurement of innovation and public-private partnerships. On these topics, she has advised many international institutions such as Competition Commission, European Commission, Financial Service Authority, OECD, OFT,

IFAD-UN and World Bank. • Roig Melcior Rosselló (Visiting Professor, Facoltà di Economia, Rome, from February to June 2018 and from September 2018 to March 2019)



Melcior Rosselló Roig is a research fellow at City, University of London and affiliated researcher at London School of Economics and Political Science, where he was previously a LSE fellow at the department of Social Policy. He studied for his BA. in Economics at UPF (Barcelona), an MSc in Health Economics and Policy at BGSE (Barcelona) and later pursued a PhD in Economics at City, University of London. His research is at the borders of health economics and political economy. More broadly, he is interested in policy relevant aspects about improving people's lives, keeping in mind

that resources are scarce. He is currently working on which are the implications of adverse household environments on a healthy upbringing alongside trying to understand the learning curves of medical doctors in Italy. He is currently visiting the Department of Economics and Finance at the Università Cattolica del Sacro Cuore in Rome.

• Gobbi Alessandro (RTD-A, Facoltà di Scienze Bancarie, Finanziarie e Assicurative, from December, 1st 2017)



Alessandro Gobbi graduated at Politecnico di Milano, where he also received a PhD in Management, Economics and Industrial Engineering. He then was a Postdoctoral Fellow in our department and at the University of Pavia.

His research interests are in the areas of applied time series econometrics, learning in macroeconomics, and monetary policy.

His current research is on the interactions of

monetary and fiscal policy in DSGE models with Markov-switching parameters, on the size of fiscal multipliers at the zero lower bound, and on the effect of heterogeneity in expectations on the transmission of monetary policy shocks.

Alessandro is also a member of the Complexity Lab in Economics.

• Panebianco Fabrizio (RTD-A, Facoltà di Economia, from December, 1st, 2017)



After getting my PhD in Economics and Ca' Foscari University in Venice, with visiting periods at NYU and Duke, I had post doc postitions in Milano Bicocca, Paris School of Economics and Bocconi University.

I develop my research along two main lines. First, cultural transmission theory, with particular interest at the diffusion of preferences, behaviors, and social norms, and their economic consequences. Second, network theory. My effort is to merge these two lines of research analyzing the

diffusion of behavior and norms in societies characterized by interactions on networks. My works have been published in Journal of Economic Theory, Journal of Economic Behavior and Organization, PLoSOne, Journal of Economic Psychology, and other minor journals.

• Luca Salmasi (RTD-A, Facoltà di Economia, Rome, from March 1st, 2017)



Luca Salmasi is Assistant Professor of Economic Policy at the Catholic University of the Sacred Heart, Rome. He obtained a PhD in Economics from the University of Verona (Italy) and was a visiting scholar at the Institute for Social & Economic Research (ISER) at the University of Essex (UK). Previously he was Assistant Professor of Political Economy at the Department of Political Sciences of the University of Perugia. His research focuses on health economics with a specific interest for applied econometrics

and public policy evaluation. Recently he analyzed the positive externalities of immigrants' regularizations in Italy in terms of newborns' health. He is currently working on the effects of immigrants' integration on fertility and health, the relationship between immigration and productivity of maternal health care services, the use of Big Data in medical research, and the analysis of the efficiency of health care systems.
